It is the intention of The Children's Challenge to take the concept of primary school focused Expedition Societies into increasingly deprived areas of the UK. The greatest impact will likely be made within these communities.

History

The Children's Challenge was established in 2017 to raise money for charities through testing and extremely rewarding events for children. These took the form of either long distance treks for parents and their children to undertake together or cross-country events for children and their friends to complete as a team.

At the beginning of 2020, the concept of community Expedition Societies, embedded within primary schools, was born. The social benefit is maintained through the benefits that accrue to all participating families and the subsidisation of children on free school meals.

During the period of home schooling, a number of free inter-school Virtual Challenges were created to encourage families to remain active and to work together towards a common goal. These events have proven to be tremendously popular with schools, children and parents alike.

The provision of the school Virtual Challenges led to The Children's Challenge undertaking bespoke Virtual Challenges for Corporates. These are essential in cross subsidising the Expedition Societies and Virtual Challenges that primary schools continue to enjoy.

Expedition Societies

The origin of The Children's Challenge is the organising of highly memorable weekend family adventures. Through Expedition Societies, these are now 'owned' by schools but remain powered entirely by The Children's Challenge.

No resources are required from participating schools and all expeditions are organised and undertaken with no teacher involvement.

In addition to community expeditions, under the auspices of the Expedition Societies, communities have been exposed to first aid training. Going forward, health and nutritional advice and Mountain Training UK accredited Hill & Mountain Skills courses will also be offered.

The aspiration is to give families, of all demographics, the confidence and competence to undertake their own outdoor adventures. By doing so, this increases the accessibility of the UK's hills, rivers, seas and mountains and ensures that the mental and physical benefits are available to all.

Virtual Challenges - Schools

The Children's Challenge organises national Virtual Challenges for primary schools. What differentiates these Virtual Challenges is the element of inter-school competition which significantly increases the level of engagement and really brings these events to life.

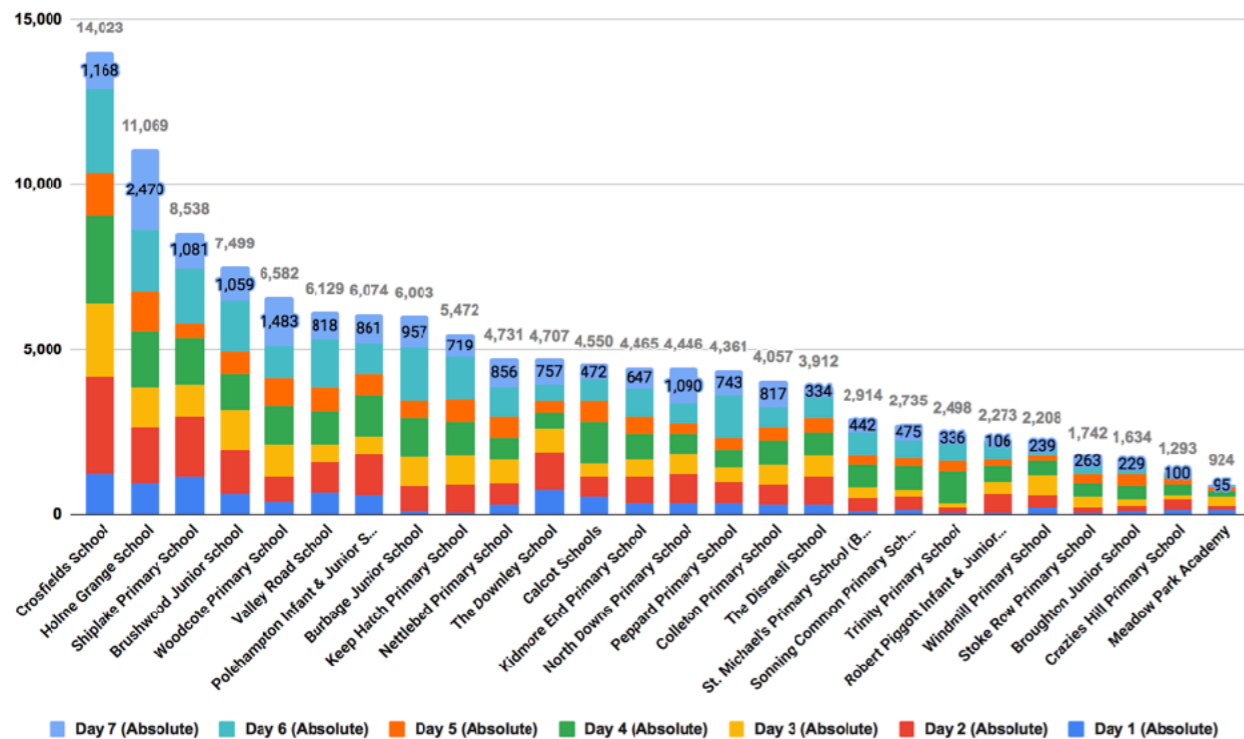
There will be three primary school national Virtual Distance Challenges every year. It is hoped that through corporate sponsorship these events will remain free for all participants. There is no administration required from the school.

These events are designed to:

- Physically challenge families.
- Engender a sense of community and teamwork through competition.
- Where desirable - be a centrally organised, fund raising opportunity for schools. This saves schools both valuable time and money.

To date, the historic Virtual Distance Challenges have been a tremendous success with over 100 primary schools representing over 30,000 pupils participating. Each event is hugely competitive and tremendously engaging for the children and teachers alike.

Past Events

Feb 2021: National Half Term Distance Competition

28,000 children registered to participate via their schools. Free for all participants.

Oct 2020: “Walk to School” Competition

4,654 children registered to participate via their schools. The event was designed to promote health & fitness and raise funds for primary schools.

July 2020: Big Outdoor Art Challenge

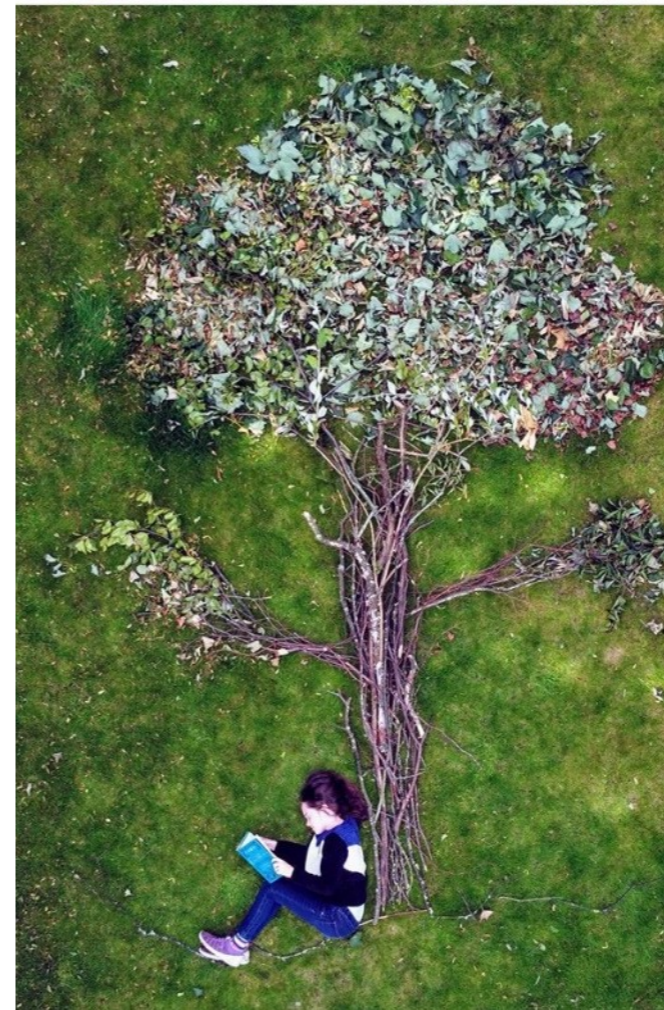
248 schools registered to participate with 500 submissions of outdoor art. Free for all participants.

May 2020: New York City Marathon

90 year groups from across the country competing against each other. Free for all participants.

May 2020: London to Cairo Duathlon - This challenge was for a school to alternately walk/cycle the 3,509 km from London to Cairo. 26 schools participated with, on average, 2,786 participants each day. Free for all participants.

April 2020: Land’s End to John O’Groats - The inaugural event was for pupils, parents and school staff to collectively walk/run the 1,407km from Land’s End to John O’Groats in one week. 6 schools took part with, on average, 527 participants per day. Free for all participants.

Virtual Challenges - Corporates

The Children's Challenge Virtual Challenges are highly differentiated through internal competition, significantly increasing the level of engagement. There is no limit to the level of customisation that can be achieved.

Corporates receive:

- A fully customised Virtual Challenge.
- A bespoke webpage hosted by The Children's Challenge for all participants to log their distance and to monitor their progress. The webpage hosts photographs taken by participants to inspire and encourage others.
- Motivational narrative to accompany the league tables, enhancing the sense of competition and the level of engagement. This is a huge differentiator and personalises the event to really bring a Virtual Challenge to life.

Philanthropy

Corporate support allows the costs for families whose children are on free school to be subsidised. The aim is to enable all families to participate in the expeditions, regardless of their individual circumstances, promoting greater community cohesion.

Corporate support also allows The Children's Challenge to move increasingly into more deprived areas where the percentage of pupils at primary schools on free school meals is considerably above the national average. The greatest impact will likely be made within these communities. These communities can be selected by corporates, potentially based on the location of their employees or customers.

There are three main ways that corporates can get involved and support The Children's Challenge:

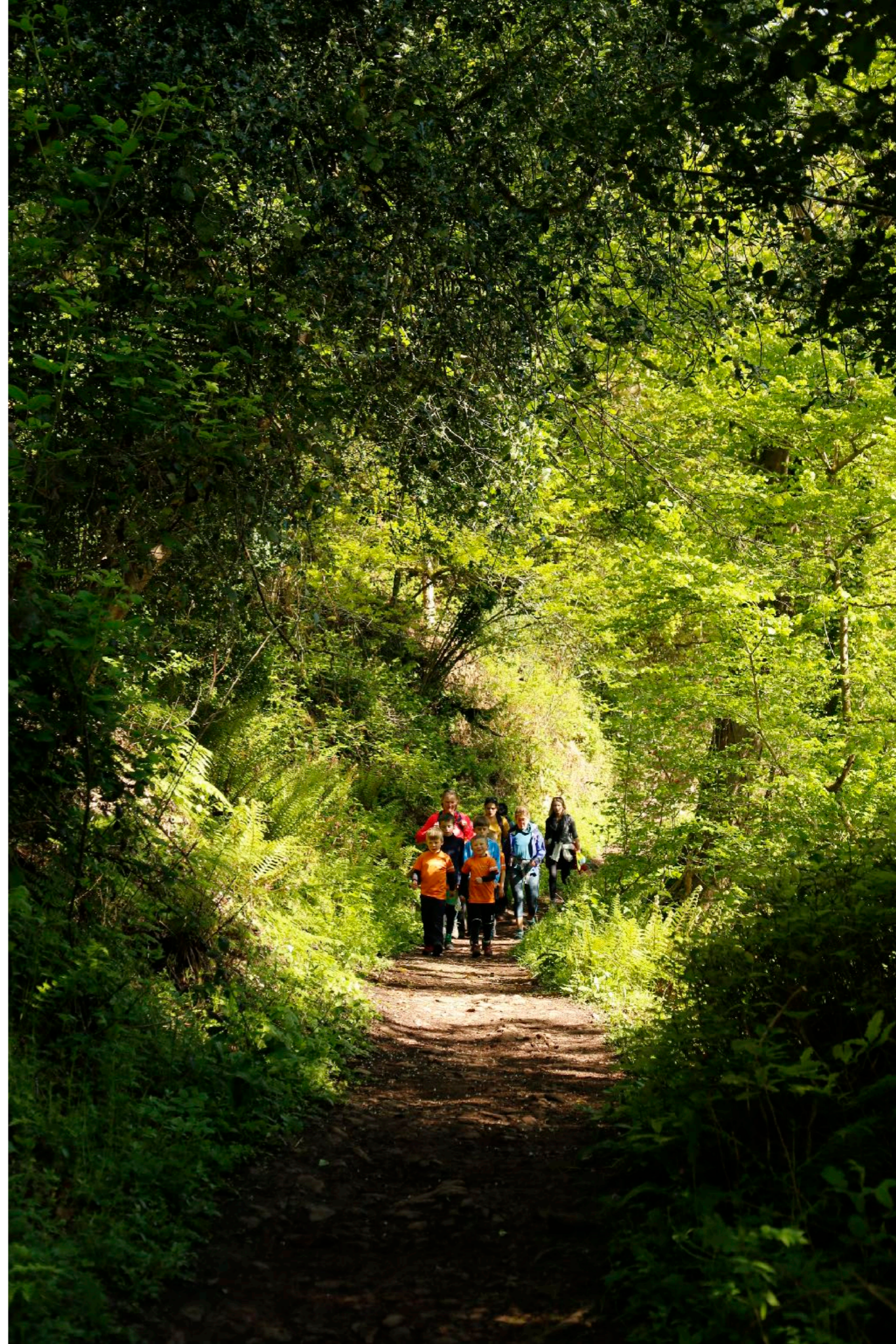
